

## Physician Selection for Occupational Injuries/Diseases

To apply for benefits under the Workers' Compensation Act, VCU Employee Health Services *must* receive *both* this *completed* claim form and the Accident Report of Workers' Compensation form by hand delivery or by mail:

- **Deliver to:** VCU Employee Health Services, 1200 East Broad Street, West Hospital, West Wing, First Floor, Room 120
- **Mail to:** VCU Employee Health Services, P. O. Box 980134, Richmond, VA 23298-0134

In case of an emergency, one initial Emergency Room (ER) visit to any hospital will be authorized under workers' compensation. Managed Care Innovations (MCI) will determine payment of services. Following any ER treatment, you must select one of the panel physicians listed below.

You are required to keep all appointments with the selected physician and accept the treatment recommended by that physician as well as any other physician or medical care provider(s) to whom you are referred.
